Here is the Bylaws change.

Section 4(Old) Upon presentation of a new candidate for membership, any club member with a reason why the individual should not be considered must inform one of the Executive Committee members of his reasons. The Executive Committee shall re-evaluate the candidate to determine if the reasons given are substantial enough to warrant exclusion from the club. If the Executive Committee finds no reason to exclude the candidate, he will be voted on at the next regularly scheduled club meeting. The sponsor/sponsors, but not the candidate, must be present for the voting.

Section 4(New) The Membership Committee Chairman or Commodore shall present a new candidate to the Executive Committee for membership into ECOMC providing the membership cap for Regular and Probationary Members is less than 200. The Executive Committee shall evaluate the new candidate to determine if the Candidate is worthy to become a Probationary Member. The Executive Committee shall vote to approve the candidate to become a Probationary Member. Probationary Member's shall serve a probationary period of at least 12 months and have all the rights, duties, and privileges of a regular member except they are not allowed to vote at club meeting. The Executive Committee shall determine when the Probationary Member's probational period is completed or if the Probationary Member should be dropped from membership of ECOMC. Any club member with a reason why the Probationary Member should not be considered for regular membership must inform one of the Executive Committee members of his reasons. The Executive Committee shall re-evaluate the candidate to determine if the reasons given are substantial enough to warrant exclusion from ECOMC. The Executive Committee shall schedule a vote with the membership at the next regularly scheduled club meeting once the Probationary member has successfully completed his probationary period.

Reasoning.

Currently new candidates for membership are brought before the executive committee where they must receive a unanimous vote. The Executive committee almost always votes to the advance the candidate for the membership vote. The membership usually approves the candidate by show of hands without discussion.

Why?

The answer is obvious. Neither the Executive committee nor the membership usually knows who we are voting on.

The new bylaw will not change how we vote candidates into the club. It will simply delay the vote until after their probationary period. Hopefully this will give us time to know who we are voting on.

Topics of discussion:

How long is the probationary period?

A minimum of 12 months, but how long? The text is written to give the Executive committee flexibility in cases where the Probationary Member has medical, work, or other issues during the probationary period that would prevent him for completing his requirements.

What should the minimum probationary period be?

This should be a topic for discussion for the membership. There is really no down side for a 2 year minimum probationary period. Currently we have several members who have completed their one year probationary period and then they quit participating. The membership needs to give the Executive Committee guidance on this issue.
